### **A Resolution Regarding the Placement of Documents on the Town of Dovre Web Site and Maintenance of Such Documents and Providing a Time Certain For Compliance**

**WHEREAS, the Town of Dovre has developed and maintained a web site on the internet in an effort to make certain documents and information available to the public, and;**

**WHEREAS, the Clerk-Treasurer of the Town of Dovre has been directed to maintain the web site and to place certain documents on the web site by the Town of Dovre Board of Supervisors, and;**

**WHEREAS, THE Clerk-Treasurer has failed to place documents on the web site as directed by the Town of Dovre Board of Supervisors, including, but not limited to Resolutions adopted by the Board in December of 2013 and January of 2014.**

**NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors for the Town of Dovre hereby directs the Clerk-Treasurer to immediately ensure that the following documents are available on the Town of Dovre web site:**


- The agendas for all meetings of the Town Board;**

- All Ordinances adopted by the Town Board, including amendments thereto;**
- The Non-Metallic License Agreement Template adopted by the Town Board, including amendments thereto;**
- The Operations Agreement Template adopted by the Town Board, including amendments thereto;**

- All Operations Agreements entered into with silica sand companies, including amendments thereto;
- The Road Use Template adopted by the Town Board, including amendments thereto;
- All Road Use Agreements entered into with silica sand companies, including amendments thereto;
- The Conveyor –Road Crossing Template adopted by the Town Board, including amendments thereto;
- All Conveyor-Road Crossing License Agreements entered into, including amendments thereto;
- Annual budget documents adopted by the Town Board, including amendments thereto;
- Annual audit reports received and approved by the Town Board, and;
- Such other documents that the Town Board may direct be placed on the Town of Dovre web site from time to time, and;

BE IT FURTHER RESOLVED that all such documents shall be made available on the Town of Dovre web site no later than 12:00 pm on ~~Friday, March 27, 2015~~, and;

BE IT FURTHER RESOLVED that the if the Clerk-Treasurer fails to comply with this Resolution, the Town of Dovre Board of Supervisors hereby authorizes its legal counsel to seek a Writ of Mandamus in Barron Circuit Court seeking enforcement of the terms of this Resolution.
